

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to the <https://www.theatre40.org> and Theatre Forty Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Theatre Forty Inc. include <https://www.theatre40.org> and Theatre 40. The Theatre 40 website is a ecommerce site. By using the Theatre 40 website, you consent to the data practices described in this statement.

TRUSTe Privacy Program

Theatre 40 is a licensee of the TRUSTe Privacy Program. TRUSTe is an independent organization whose mission is to build users' trust and confidence in the Internet by promoting the use of fair information practices. Because we want to demonstrate our commitment to your privacy, we have agreed to disclose our information practices and have our privacy practices reviewed for compliance by TRUSTe.

Collection of your Personal Information

Theatre 40 may collect personally identifiable information, such as your name. If you purchase Theatre 40's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by Theatre 40. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Theatre 40 website.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Theatre 40's public message boards, this information may be collected and used by others.

Theatre 40 encourages you to review the privacy statements of websites you choose to link to from Theatre 40 so that you can understand how those websites collect, use and share your information. Theatre 40 is not responsible for the privacy statements or other content on websites outside of the Theatre 40 website.

Use of your Personal Information

Theatre 40 collects and uses your personal information to operate its website(s) and deliver the

services you have requested.

Theatre 40 may also use your personally identifiable information to inform you of other products or services available from Theatre 40 and its affiliates. Theatre 40 may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Theatre 40 does not sell, rent or lease its customer lists to third parties.

Theatre 40 may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Theatre 40, and they are required to maintain the confidentiality of your information.

Theatre 40 may keep track of the websites and pages our users visit within Theatre 40, in order to determine what Theatre 40 services are the most popular. This data is used to deliver customized content and advertising within Theatre 40 to customers whose behavior indicates that they are interested in a particular subject area.

Theatre 40 will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Theatre 40 or the site; (b) protect and defend the rights or property of Theatre 40; and, (c) act under exigent circumstances to protect the personal safety of users of Theatre 40, or the public.

Use of Cookies

The Theatre 40 website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Theatre 40 pages, or register with Theatre 40 site or services, a cookie helps Theatre 40 to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same Theatre 40 website, the information you previously provided can be retrieved, so you can easily use the Theatre 40 features that you customized.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of the Theatre 40 services or websites you visit.

Security of your Personal Information

To secure your personal information from unauthorized access, use or disclosure, Theatre 40 uses the following:

When personal information (such as a credit card number) is transmitted to other websites, it is protected through the use of encryption, such as the Secure Sockets Layer (SSL) protocol.

Verisign is an independent, third-party company engaged in the development of digital trust. Verisign provides authentication of Internet services, digital identity and intellectual property. By clicking on the Verisign logo, the Verisign website will serve up a web page that confirms that Theatre 40 is "Verisign Authenticated."

Children Under Thirteen

Theatre 40 does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.
